<u>Impartial Investigations</u>: Conduct fair and unbiased investigations into complaints, ensuring that all parties are given an opportunity to be heard.


Evidence Collection: Gather and document evidence, including witness statements, digital records, and physical evidence, to build a comprehensive case file.
