Venkatacharyulu said that by learning these tax procedures, there will be employment opportunities not only in the current situation but also in the future on the calculation of tax procedures.Commerce Lecturer Ch. Ramadevi said that GST is divided into four types namely State GST Central GST Integrated GST ,Union Territory GST, and explained about GST rates. K.V.V Sirisha said that the differences between direct taxes and indirect taxes were explained. Principal of the college, teachers of commerce department and B.Com students participated in this program.
