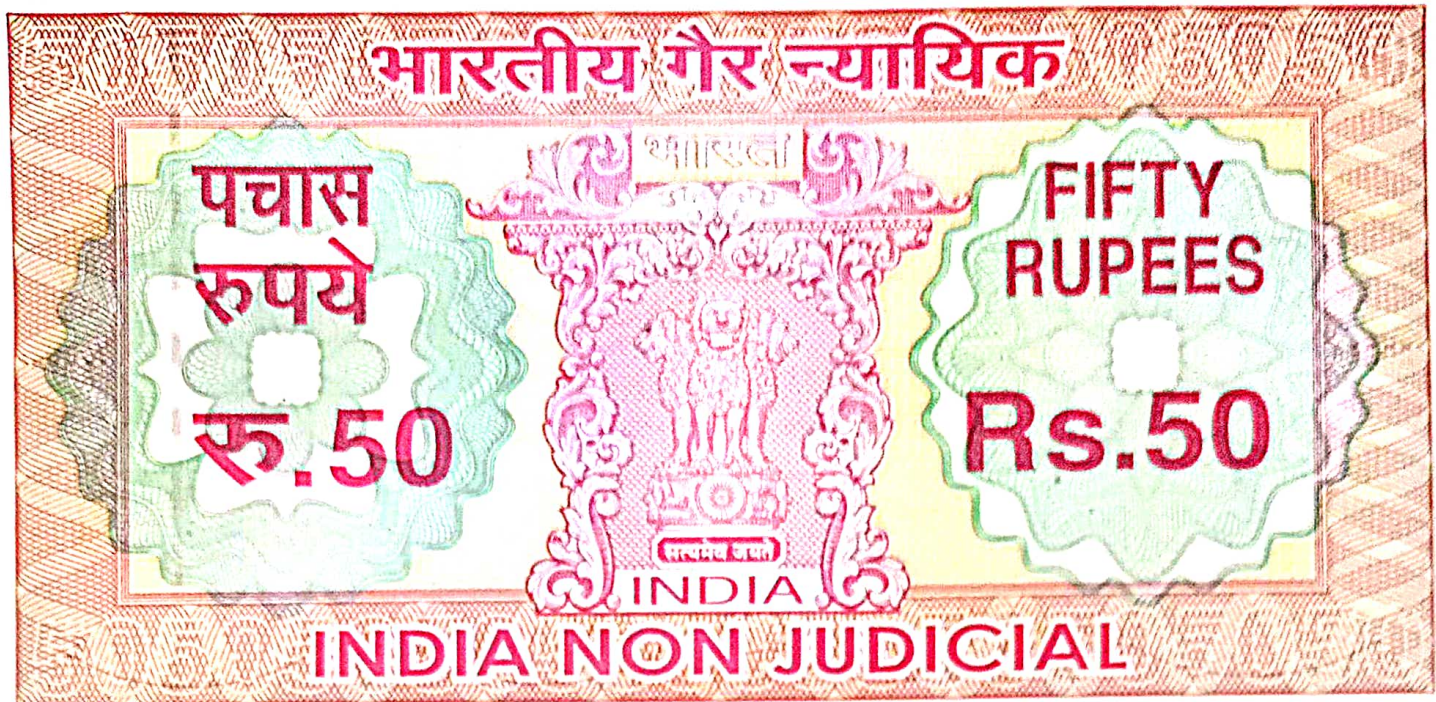

4. To exchange services of faculties, experts and staff.


AREA OF COLLABORATION:
